These minutes are an overview of the meeting; not a verbatim text.

The meeting was called to order at 7:01pm by Commissioner Caporale.

## 1. APPROVAL OF MINUTES

Commissioner Caporale made a motion to accept the minutes of the Police Commission Meeting of September 14, 2023. Commissioner Coffin made a motion and Commissioner Dornfeld seconded the motion.

# Minutes of September 14, 2023 Police Commission Meeting accepted as written.

Commissioner Money made a motion to add the following paragraph to the Police Commission Special Meeting minutes of September 20, 2023 on page 4 following Commissioner Dornfeld's motion to approve Ridgefield Pride's Application to paint a crosswalk in rainbow colors with the following conditions. Commissioner Money seconded the motion.

Commissioner Money asked the Chief if he viewed the guidelines contained in the MUTCD to cover not only the original crosswalk proposal but also cover the driveway motion put forth by Commissioner Dornfeld's current motion. The Chief answered affirmative and that he would apply the same guidelines to both crosswalks.

# Minutes of September 20, 2023 Police Commission Special Meeting accepted as presented.

#### 2. PUBLIC COMMENT

Jason Geane from 219 Mamanasco Road presented to the Police Commission his concern for the speeding traffic on Mamanasco Road. Approximately 10+ residents were present supporting this issue. Jason explained that Mamanasco Road is used as a cut through to get to the high school. Jason feels that it is just a matter of time before someone gets hurt, definitely not safe, with drivers showing a lack of respect to the residents. The worst time is 7:00am when students are going to school and about 2:00pm coming home from school, plus events on the weekends. He, along with the other residents present, want something to be done before someone gets hurt. One resident stated it is out of control, stating it is irresponsible when you can hear speeding cars over a conference call. One resident from 239 Mamanasco Road stated they live 1/4 mile from the high school and they're kids can't walk to school because it is too dangerous. A resident from 177 Mamanasco Road expressed similar concerns stating the traffic has gotten worse.

Commissioner Dornfeld stated we can explore other speed reducing options. Asked what the high school policy is on parking.

The residents questioned about what could they do. Major Platt stated they could bring it to the attention of the Board of Education to see if there is any assistance that the school can offer to deter the influx of vehicles during these times.

Major Platt agrees 100% with their concerns. He explained that there has been speed enforcement on Mamanasco Road multiple times this week. Residents explained that there needs to be more focus during the after-school times. He will follow up with Patrol Capt. Fowler to strategize to help alleviate the problem. The residents were appreciative for having the opportunity to speak to the Police Commission about this issue. The residents were thanked for bringing this to our attention.

## 3. COMMISSION CORRESPONDENCE

#### A. Voicemail

Commissioner Caporale stated there were no voicemail received for the month of September.

#### **B. Written Correspondence**

The Police Commission received a letter from Dan Tewes and John Loehr from Main Street concerned about the speed of traffic on Main Street. That combined with local traffic, bicyclists and pedestrians this is increasingly hazardous. Chairman Frey stated the guidelines for Main Street aren't out yet. He sent them an email encouraging them to come to a meeting.

A letter was also received from the Connecticut Department of Transportation (CTDOT) stating the lower east section of Branchville Road as one of the areas they have tentatively planned to possibly resurface with installation of centerline rumble strips (CLRS). This is a cost-effective, safety countermeasure to help reduce head-on collisions and sideswipe crashes. The letter was signed by First Selectman Rudy Marconi approving such measure. Commissioner Coffin stated the Police Commission also approve.
