# C. DEPARTMENT STATS

Chief Kreitz stated the total number of incidents for the month of January 2024 was 1,580. He highlighted some of the statistics for the month.

Chief Kreitz stated that he spoke with State Representative Aimee Berger-Girvallo, Vice Chair of the Transportation Committee, regarding the traffic backup on Danbury Road in the area of Copps Hill. Chief Kreitz stated that the backup is caused by the timing of the traffic control signals at the Danbury Road/Copps Hill Plaza and the Danbury Road/Farmingville Road intersections. Chief Kreitz stated that the State DOT has been notified numerous times regarding the timing, however, due to the age of the signal at Copps Hill Plaza the timing cannot be improved. He noted the signal at Danbury Road/Farmingville Road intersection was updated a few years ago. Chief Kreitz stated that this is an ongoing issue and that he believes if the traffic control signal is updated at Danbury Road/ Copps Hill Plaza traffic will flow better through the area because the lights can communicate more efficiently. State Representative Aimee Berger-Girvallo stated that she spoke with the State DOT and an onsite visit is going to be scheduled in the near future.

Chief Kreitz also mentioned that the Ridgefield Police Department is offering Citizens Police Academy every Wednesday night, from March 20<sup>th</sup> – May 8<sup>th</sup>, from 6pm – 9pm. This is a great opportunity to learn all about the Police Department and how they protect and serve the citizens of Ridgefield. You can go to the Police Department website to sign up.

Chief Kreitz stated positive feedback was received from enforcing the speed limit.
