The meeting was called to order at 7:00pm by Chairperson Dornfeld.

1. APPROVAL OF MINUTES

Chairperson Dornfeld requested a motion to accept the minutes of the October 10, 2024 Police Commission Meeting. Commissioner Money made a motion and Commissioner Coffin seconded the motion.

2. PUBLIC COMMENT

Karen Albright from 4 Mountain View Avenue, along with other area residents, presented to the Police Commission their concern about the proposed plan to build condos on the now Red Rooster property located at 43 Danbury Road. Karen presented to the Police Commission a report from the Connecticut Crash Data Repository stating that there have been numerous crashes in the area over the last 10 years. Karen stated that they are not opposed to the development but are concerned over safety. Their concern is traffic, both pedestrian and vehicular. Chief Kreitz stated Planning & Zoning has not come to him yet about the proposed project. Chief Kreitz, along with the Police Commission, suggested that they find out when the Planning & Zoning meeting will be concerning this project and present their concern, along with their data and state any questions or concerns that they have.

3. <u>NEW BUSINESS</u>

A. Division of Professional Standards Annual Report

Capt. Jeff Raines, Division of Professional Standards, thanked the police commission, and stated that he has enjoyed the past three years in this position. He gave an overview of his role. One aspect is being in charge of training being it mandatory or optional. He stated how well trained the officers are. That there are 12 certified instructors, DARE officers, Citizens Police Academy, Junior Police Academy and SRO officers to name a few. Chairperson Dornfeld, along with the other police commissioners, acknowledged the amount of training the officers have. The Board of Police Commissioners acknowledged him for his dedication to the department.
