These minutes are an overview of the meeting; not a verbatim text.

The meeting was called to order at 7:02pm by Chairperson Dornfeld.

1. APPROVAL OF MINUTES

Chairperson Dornfeld requested a motion to accept the minutes of the April 10, 2025 Police Commission Meeting. Commissioner Money made a motion and Commissioner Coffin seconded the motion.

2. PUBLIC COMMENT

Tom McManus, Tree Committee, stated 16 new established trees have been planted on Main Street. His concern is there is damage to one of the trees caused by a car accident. He stated he received a copy of the accident report but he would like Steve Lavatori, Tree Warden, notified if a tree is damaged. Chief Kreitz stated Records would inform Steve when necessary.

Christopher Rees, from 4 Mountain View Avenue, presented to the Police Commission stating his concerns of traffic at 43 Danbury Road Development, formerly Red Rooster. He stated that Danbury Road in this area is over capacity at peak hours, that there is extensive queuing, and that he and his neighbors have concerns for the proposed right turn only, as well as vehicle and pedestrian safety. Mr. Rees has a PowerPoint presentation which included a video in front of Red Rooster showing Danbury Road congestion at the site. Some of those in attendance who stated their concerns were Renee Whitworth from 17 Mountain View Avenue, Mary Pieriandri from 3 Hillsdale Avenue, Barbara Baughman from 5 Mountain View Avenue and Nicola Tizi from Mountain View Avenue. In summary, all were concerned that Danbury Road is over capacity at peak hours, right turn only and lack of sidewalks. All were concerned that this project would increase vehicle and pedestrian traffic in the area creating a safety issue.

4. OLD BUSINESS

A. Review of P&Z Plans – 43 Danbury Road Presentation by Pete Olsen and Joe Belskus

Peter Olsen, along with Joe Belskus, re-presented their plans for 43 Danbury Road, formerly Red Rooster, to the Police Commission their plans for 20 residential apartments. A study was presented by Joe Belskus who stated Danbury Road is not dangerous, a crash history from 2021-2024, and that the proposed would not generate a lot of traffic. The Board of Police Commissioners comment on the proposed project:

Comments:

The objective data provided by the Applicant in its April 22, 2025 addendum to the Applicant's traffic study does not provide a safety basis for the Traffic Authority to object to the proposed plan.

Nevertheless, the Police Commission acting as Traffic Authority has the following comments:

By observation, the stone wall on the south side of the existing driveway (toward the Mobil station) impairs the line of sight to the south and should be removed or relocated.

The "right turn only" requirement should be reinforced with a forced turn island similar to the one installed opposite Roberts Lane in the driveway serving Webster Bank and Bobo's café.

There are four existing curb cuts west side of Danbury Road between Roberts Lane and Mountain View Avenue – a distance of just 331.3 feet. Members of the public report a perceived sense of heightened danger when traveling along that portion of the roadway due to the number of vehicles turning into and out of the commercial properties on Danbury Road and the proximity of the Mobil Station and Holly Nails driveways with each other and to the traffic light serving the T-intersection with Grove Street. Page 10 of the April 22, 2025 addendum to the Applicant's traffic study notes the recommendation dating to 2005 "that consolidation of driveways be considered," but proposes that such consideration should take place "when adjacent property is redevelopment (sic)" but concludes that "[t]he existing driveway is not suitable [*missing language*] accommodating redevelopment at this time" without explanation. The Traffic Authority would encourage the *current* consideration of this option.

While individual projects which increase traffic density may not separately constitute a safety hazard, the Traffic Authority remains concerned about the cumulative effect of continued development and increased volume of traffic.

Chief Kreitz stated Jake Muller has been working with Kaestle Boos for potential design modifications.
