## 1. APPROVAL OF MINUTES

Motion made by Ralph Money to approve the October 2025 meeting minutes. Seconded by Marcie Coffin. Motion carried 5-0.

# **B.** Written Correspondence

- Hwy Use Permit Applications were reviewed for 1) BGCR Turkey Trot, 2) Chamber's Holiday Stroll & 3) Chamber's Sip & Stroll. All permits were approved by the Police Commission.
- A resident of Quail Ridge emailed their concerns about speeding, cars parking on Prospect Ridge, and poor visibility/lighting. Chief Kreitz will ask the Sign Officer to review current signage in that area. Ridgefield Men's Softball will be contacted to remind players to park in parking spaces.
- Discussion took place regarding a request from the Town Parking Authority to prohibit oversize vehicle parking on Main Street. Chief Kreitz, and the Police Commission would like to better understand the Parking Authority's recommendation before proceeding. Chair Dornfeld agreed to follow up with the Parking Authority in writing.

  - 1) Madeline Dr. resident requested the speed limit be lowered from 25 mph to 15 mph. The Department recommends lowering the speed to 20 mph.
    - Motion made by John Frey to lower the speed limit from 25 mph to 20 mph on Madeline Dr. Seconded by Issy Caporale. Motion carried 5-0.
  - 2) Playground Rd. resident requested more enforcement of the no parking signs during baseball season.
