Meeting called to order by Chair Sharon Dornfeld at 7:02 pm.

1. APPROVAL OF MINUTES

Motion made by Ralph Money to approve the September 18th meeting minutes and the October 2nd Special Meeting Minutes. Seconded by John Frey. Motion carried 4-0.

2. PUBLIC COMMENT

No members of the public were in attendance.

3. COMMISSION CORRESPONDENCE

A. Voicemail

- Commissioner Caporale provided a summary of requests/concerns to Chief Kreitz and Major Fowler, including:
- A resident of Florida Hill Rd. asked when new lines would be painted on the road after the recent paving.
- A resident of Playground Rd. requested increased no-parking enforcement.
- Madeline Dr. resident wants the speed lowered from 25 mph to 15 mph.

B. Written Correspondence

- Hwy Use Permit for Main St. Tree Lighting on 11/28/25 – Approved by the Commission.
- Request from Bob Jewell for approval on the community sign located on the Fairfield County Bank property at 150 Danbury Rd. Chief Kreitz confirmed there are no site line issues or concerns from RPD, and the Commission expressed no concerns.

- **Public Safety Building Update / Public Hearing Recap**
 - Two information sessions took place earlier this month, as well as the 10/8 Public Hearing with mixed feedback.
 - Moved by Ralph Money and seconded by John Frey, the Commission went on the record with the following statement: At its regular monthly meeting on October 9, 2025, the Ridgefield Board of Police Commissioners voted unanimously to support the new Public Safety Building and encourages Ridgefield voters to Vote Yes on the November 4th referendum question.
- **CT-DOT 0174-0475 will replace existing pedestrian & school crossing signage on Rte. 116 in Spring 2026**

6. CHIEF'S REPORT

A. Traffic / Sign Report

- Repaired the Stop Sign at Stonecrest Road/ Ridgecrest Rd
- Repair 25 MPH Speed Limit sign Peaceable St
- Replaced the Stop Sign at Spectacles Ln
- (2) No Thru Truck/7 Ton Limit signs were installed on each end of Rockwell Rd
- Installed solar sign on Ridgebury Rd
- Repaired 30 MPH Speed Limit sign on Farmingville Rd
- Installed Solar Sign on Farmingville Rd
- Installed Solar Sign on Rt 7 Danbury Rd
- Installed Solar Sign on Rt 116 North Salem Rd
- Repaired the Stop sign at Farrar Lane / Tackora Trail
- Replaced 2 25 MPH Speed Limit signs on Pin Pack Rd.
- CT DOT will do the initial installation on traffic signs on Town roads that intersect State roads. If they are damaged or need replacement, it will be the Town's responsibility to fix/replace. This will require that compatible sign parts be purchased.
- Sgt Seibert has begun his training as sign officer, including the required classroom and field training. The Commission extends their best wishes to Sgt. Seibert as he takes on these additional duties.
