

# Town of Ridgefield Police Commission Meeting Minutes Thursday, September 18, 2025 at 7:00 pm Meeting Location: Town Hall Annex, 66 Prospect Street APPROVED

Meeting called to order by Chair Sharon Dornfeld at 7:02 pm.

#### 1. APPROVAL OF MINUTES

Motion made by Ralph Money to approve the July 10<sup>th</sup> meeting minutes. Seconded by John Frey. Motion carried 4-0.

## 2. PUBLIC COMMENT

Andi Mead and Kevin Collins of Rockwell Rd. shared their concern about an increase in heavy-duty truck traffic using the road as a pass-thru, and requested a No Thru Trucks sign be installed. Chief Kreitz agreed to look into their concern, and should the situation warrant it, will request a sign be installed sometime this fall.

During the month of July, the Department participated in 27 community policing and public relations events, including engaging residents at local houses of worship, local business owners, staff and residents of Ballard Green, and provided citizen ride-alongs. Social media was used to highlight public safety for e-bikes, communicate road closures, introduce new staff, and share monthly department stats. Some of the events Officers participated in include,

In August, the Department participated in 20 community policing and public relations events with a special focus on back-to-school safety, and new state regulations regarding E-bikes that take effect this fall. Officers met with school officials and parents regarding back-to-school related concerns, including safe driving laws for new teen drivers.
