Town of Ridgefield Police Commission Meeting Minutes

Meeting called to order by Chair Sharon Dornfeld at 7:01 pm.

1. APPROVAL OF MINUTES

Motion made by Stephen Riebling to approve the December 2025 meeting minutes.
Seconded by Issy Caporale. Motion carried 5-0.

2. PUBLIC COMMENT – None

Motion by Chair Dornfeld to move New Business after public comment in consideration of Cpt. Raines' time. Seconded by Stephen Riebling. Motion carried 5-0.

3. NEW BUSINESS:

A. Uniform Division Commanders' Annual Report

- Cpt. Jeffrey Raines presented an annual summary of the Uniform Division responsibilities, achievements and stats to the Commission. The Commission expressed their gratitude for the exceptional job the Patrol Division is doing for the Town.

6. CHIEF'S REPORT

A. Traffic / Sign Report – Submitted by Sgt. Matthew Seibert

Sign Repair/Maintenance:

- Emailed the State about a speed limit sign on Rte. 7 near the Branchville train station needing to be installed, and the improper speed limit sign that was replaced on Rte. 116 due to an accident (35mph limit instead of 30 mph).
- In response to the Prospect Ridge complaint, the State installed a data counter temporarily (12/4-12). The data showed the following:
 - Total # of vehicles between 12/4 and 12/12 was 7,245
 - Average daily traffic was 891

Percentile	15%	50%	85%	95%
Speed	20	24	29	31

- Mean Speed (Average) 25.3 mph
- 10 mph Pace Speed: 21-30
- Number in Pace: 5,343
- Percent in Pace: 74.0%
- Number > 45 MPH 5
- Percent > 45 MPH 0.1%

Overall, this is a low rating for the area, so I would not recommend any changes at this time. I reached out to the resident and spoke with him in regards to the results from the data.

- Chief Kreitz and Major Fowler met with the First Selectperson and Finance regarding the FY2027 budget request. Next steps will be to present the budget to the BOS.

7. UNION PARTICIPATION – No Union business was discussed.

8. MISCELLANEOUS

- Discussion took place regarding the BOS' most recent meeting where they discussed selecting members for the new Police and Fire Facilities Committee.
- Motion made by Ralph Money and seconded by John Frey that the Board of Selectpersons include members of the Board of Police Commissioners as ex officio participants in the interview process to select members of the new Police and Fire Facilities Committee. Such participation is necessitated by State Statute and Town Code, consistent with past practice of joint BOS and BOPC facilities planning for the Fire and Police Departments, and would promote transparency with the public. Motion approved.

With no further business, Ralph Money moved to adjourn the meeting at 8:15pm. Issy Caporale seconded the motion. Motion approved.
