

Town of Ridgefield November 24, 2025 Special Meeting of the Board of Selectpersons Unapproved/Unrevised Minutes Town Hall Large Conference Room 3:30 pm

Minutes:

Rudy Marconi called the meeting to order at 3:43 pm.

Maureen Kozlark motioned to enter executive session inviting Scott Bristol, LEP via phone to discuss the Property Purchase Review of 217 Danbury Road. Maureen Kozlark also acknowledging they would be inviting HR Director, Laurie Fernandez, Fire Chief Duckworth, Assistant Fire Chief Cerulli and the candidates for their portions of the agenda for Fire Fighter interviews, discussion of Deputy Fire Marshal Appointment, and finally just HR Director Fernandez for the UPSEU Tentative Agreement and the Police Major Employment Contract.
