Rudy Marconi called the meeting to order at 6:30 pm.

**1. Public Comment**

**2. Appointments and Reappointments**

- a. **Historic District Commission** – The candidates introduced themselves and described their interest and participation on the committee. The committee answered BOS questions regarding disagreements and preservation. The committee explained that alternates participate as much as full members. The committee discussion seeks unanimity on issues. Applications are considered individually while also evaluating community impact. Precedence is not a true issue because no two properties are identical. The committee's philosophical approach to policy and preservation focuses on flexibility, but no charter or bylaws are explicitly stated.

***Maureen Kozlark motioned to appoint Mark Blandford, Kam Daughters, and Harriet Hanlon to the Historic District Commission. Geoffrey Morris seconded. Motion carried 5-0.***

- b. **Ridgefield Housing Authority** – Rudy Marconi stated that the current committee finance person submitted comments supporting the appointment of this candidate. The candidate introduced himself sharing that he is a lifelong resident of Ridgefield having grown up here and now raising his own family here. He enjoys giving back to the community that has given so much to his family. He serves as a volunteer with the fire department and as his son's

school basketball coach. His finance education and project experience at Harvard and his work for the mayor of Bridgeport have shaped his views on the importance of dignified housing for all. He would like to share that experience here at home. The BOS asked about balancing multiple commitments and Housing Authority history.

**i. Indra Sen**

***Sean Connelly motioned to appoint Indra Sen to the Ridgefield Housing Authority. Maureen Kozlark seconded. Motion carried 5-0.***

- c. Conservation Commission** – The commission chair discussed recent commission activities and candidate involvement. The BOS asked about the chestnut project and any other significant projects on the horizon.

***Maureen Kozlark motioned to appoint Matt Sharp and Jana Hogan as full members, and Tony Markert as an alternate member. Sean Connelly seconded. Motion carried 5-0.***

***Sean Connelly motioned to adjourn the BOS meeting to a public hearing at 7:30pm. Seconded by Maureen Kozlark. Motion carried 5-0.***

***Barbara Manners left during the public hearing.***

***The BOS meeting continued at 8:35 pm.***

**3. Senior Tax Committee**

The BOS discussed the advantages and disadvantages of the proposed senior tax credits. While they appreciate the challenges seniors face, they also recognize that any tax credits mean shifting the burden of the town's expenses to the rest of the community. Any credit for seniors means a revenue deficit for the town. The BOS was in support of a means test for any credit but some also oppose repealing any existing non-means tested credit. The Senior Tax Committee proposed two entirely new tax credits and adjustments to two existing tax credits. The BOS was in agreement to; maintain the existing non-means tested income credit at the current amount, establish the new supplemental means-tested tax credit tied to income levels with a maximum of \$85,000, and raise the income maximum to \$85,000 for the existing Elderly Deferment Program. The BOS also considered indexing the programs to the mil rate and adding language to the ordinance to adjust the credits periodically. Draft ordinance will be prepared for the public hearing.

Various department heads have been discussing the budget. The BOS will receive the first draft next week.

The Boys and Girls Club opened in Danbury.

Rudy Marconi is meeting with the BOF to discuss short and long-term financial needs for the town.
