

# **Charter Revision Commission**

Special Meeting Minutes January 31, 2023 at 6:30pm Town Hall Small Conference Room

1. Appoint Commission Chair, Vice Chair and Recording Secretary

Motion by Mike. Rettger to appoint Rebecca Mucchetti and Bob Cascella as Co-Chairpersons of the Charter Revision Commission. Seconded by Tom. Lansen. Motion carries 9 to 0.

Motion by Rebecca Mucchetti to appoint Tom Lansen as Vice Chairperson of the Charter Revision Commission. Seconded by Derick. Schirm. Motion carries 9 to 0.
