Bob & Kay attended the WestCOG Info Sharing and Networking Event on Tuesday 9/30. Great networking event to meet with and build relationships with other local town EDC's. Of note, Town of Redding is working on redevelopment of Wire Mill with multi family housing.

Planning & Zoning – Request from Rob Hendrix to the ECDC -when doing referrals for specific requests, to only opine if it's positive or negative for the community of Ridgefield. Also looking for town boards to provide input on current regulations.

Farmers Market – successful 2^{nd} year with an increase from 9 biweekly markets to 17 weekly markets. On average, each weekly market had ~1000 attendees and an average of \$20,000 for vendors. Have received very positive feedback from the community.
