August 3, 2026	Last day to pay Motor Vehicle and 1 <sup>st</sup> installment of Real Estate and Personal Property taxes without penalty. Office open 8:00 am – 7:00 pm.
September 1, 2026	1 <sup>st</sup> installment of Sewer Use charges due.
October 1, 2026	2 <sup>nd</sup> quarterly installment of Real Estate and Personal Property taxes due.
October 1 - November 2, 2026	Personal Property declaration form must be filed with the Tax Assessor to avoid penalty. For questions, call (203) 431-2706.
October 1, 2026	Last day to pay Sewer Use 1 <sup>st</sup> installment without penalty.
October 31, 2026	Last Saturday to pay. Office open 9:00 am - Noon.
November 2, 2026	Last day to pay 2 <sup>nd</sup> quarterly installment of Real Estate and Personal Property taxes without penalty. Office open 8:00 a.m. - 7:00 pm.
Late December 2026	Supplemental Motor Vehicle tax bills mailed.
January 1, 2027	3 <sup>rd</sup> quarterly installment of Real Estate, Personal Property, and payment in full of Supplemental Motor Vehicle taxes due.
January 1 - April 1, 2027	Tax Assessor's office accepts applications for Elderly Town Benefit. For questions, call (203) 431-2706
January 1 - May 15, 2027	Tax Assessor's office accepts applications for Elderly Tax Deferment. For questions, call (203) 431-2706.
January 30, 2027	Last Saturday to pay. Office open 9:00 am - Noon.
February 1, 2027	Annual Sewer Hook-up installment payment due.
February 1, 2027	Last day to pay 3 <sup>rd</sup> quarterly installment for Real Estate and Personal Property taxes. Last day to pay Supplemental Motor Vehicle taxes without penalty. Office open 8:00 am - 7:00 pm.
March 1, 2027	2 <sup>nd</sup> installment of Sewer Use charges due (if total bill is over\$500).
March 2, 2027	Last day to pay Sewer Hook-up payments without penalty.
April 1, 2027	4 <sup>th</sup> quarterly installment Real Estate and Personal Property taxes due. Last day to pay 2 <sup>nd</sup> Sewer Use installment payments without penalty.
May 1, 2027	Last Saturday to pay. Office open 9:00 am - Noon.
May 3, 2027	Last day to pay Real Estate and Personal Property without penalty. Office open 8:00 am - 7:00 pm.
June 17, 2027	Liens filed on land records for delinquent Real Estate taxes in accordance with CGS 12-172.
