1. APPROVAL OF MINUTES

3. OPEN SPACE

Pollinator Pathway – The topic will be revisited when Ms. Snow is in attendance.

Pine Mountain – Mr. Coyle, Mr. Cronin and Agenor DeSilva cleared several trees to create the newest lookout dubbed “Flying Squirrel Ledge”. The new trail will be finalized shortly.

McKeon Farm – Mr. Coyle, Mr. Cronin and Ms. Snow met with Ms. Freeman to continue discussing the farmer’s 2018 plans. Mr. Coyle and Mr. Kace are working on Mr. Williams 2018 contract to include six steer and possibly turkeys. The discussions with both farmers have been instrumental in the creation of The McKeons’ Arigideen Farm Maintenance Manual. Mr. Coyle mentioned that the major issue facing the farm at this time is liming as the fields have not been limed for many years. Mr. Coyle and Ms. Snow are in the process of gathering information on the issue and will get back to the RCC with findings.
