



Firefighter/EMT **Firefighter/paramedics**

The Town of Ridgefield will be accepting applications for the position of **Experienced and Non-Experienced Firefighter/EMT** and **Firefighter/Paramedics** through **4:00 PM, Friday, April 26, 2024**.

Applicants **MUST** be non-smokers, in good physical condition, and of high moral character interested in a career in the Ridgefield Fire and EMS Services.

The Town is seeking Experienced or Non-Experienced Firefighter/EMT's and Firefighter/Medics

To qualify as an Experienced Firefighter EMT or Firefighter Paramedic Candidate you must possess:

- State of CT (or equivalent) Fire Fighter II certification
- State of CT EMT Certification or PARAMEDIC license
- Valid CPAT within one-year of September 2023
- Verifiable history of providing emergency medical services at the certification level applying for

To qualify as a Firefighter/EMT or Firefighter/Paramedic applicant (not experienced), you must possess:

- State of CT EMT Certificate or Paramedic License
- CPAT valid within one year of September 2023

All applicants must be at least 18 years of age and possess a valid vehicle operator's license.

Town of Ridgefield requires all candidates to have successfully passed the Candidate Physical Ability Test (CPAT), and **must provide proof of valid CPAT effective no earlier than August 28, 2022 or provide proof of enrollment and must pass the CPAT by the time of interviews in May.**

Firefighter Recruit Graduates, experienced/transferring Firefighters will be given extra consideration when we review applications.

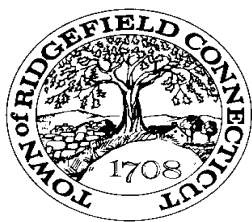
This position may work rotating 24-hour shifts or rotating 12-hour day shifts scheduled after Recruit Firefighter Training and/or department recruit training and orientation.

The full-time starting salary for a **Firefighter/EMT is \$58,772 and Firefighter/Paramedic is \$60,772 per year**. This position comes with a generous benefit package including a 401(a) with Town match and medical/dental/vision benefits. Minority and female candidates are strongly encouraged to apply. EOE.
