Special Town Meeting April 13, 2022

The First Selectman, Rudy Marconi, called the meeting to order at 7:30 pm in the large conference room of Town Hall. Mr. Marconi asked the audience to stand and recite the Pledge of Allegiance.

R. Marconi stated that the first order of business was to appoint a Moderator. **Selectperson M. Kozlark moved and Selectman Sean Connelly seconded the motion to appoint Jane Berendsen-Hill, East Ridge Road, Moderator for the Special Town Meeting. The "Aye" votes were unanimous and Jane Berendsen-Hill was appointed Moderator.**

Moderator Berendsen-Hill called the meeting to order and requested a motion to appoint a secretary. **M. Kozlark moved and R. Marconi seconded the motion to appoint Wendy Gannon Lionetti, Town Clerk, secretary. The "Aye" votes were unanimous and Wendy Gannon Lionetti was appointed secretary.**

Moderator Berendsen-Hill read the legal notice of the meeting that appears on page 410 of the Town Meeting minute book to consider approval of the budget resolution for the 2021 budget season.

The Moderator then asked for a motion to approve. **S. Connelly moved and John Katz, Ridgebury Road, seconded the motion to approve the resolution entitled "Resolution Making Appropriations Aggregating \$2,981,358 For The Planning, Design, Acquisition, Installation And Construction Of Various Board Of Education Projects And Authorizing The Issuance Of \$2,981,358 Bonds Of The Town To Meet Said Appropriations And Pending The Issuance Thereof The Making Of Temporary Borrowings For Such Purposes (Provided That The Bonds Shall Be Reduced By The Amount Of Any Eversource Rebates Received For Such Purposes, Which Are Anticipated To Be \$30,000 For Led Lighting Upgrades)."**
