1. APPROVAL OF MINUTES

3. <u>NEW BUSINESS</u> A. Plan Review – 34 Halpin Lane

Jake Muller presented the plans for 34 Halpin Ln at the December 12, 2024 Board of Police Commissioners meeting. The Board of Police Commissioners have the following comments on the proposed plans:

- A sidewalk shall be installed on the east side of Prospect Ridge and extend to its intersection with Governor Street (north side). A crosswalk shall be installed connecting the new sidewalk with the existing sidewalk on the north side of Governor Street.
- Discernable boundaries shall be present between the school property/parking area and public parking area. The purpose of this is to clearly delineate the two properties.

B. Proposed Temporary and Limited Development Moratorium

The Board of Police Commissioners takes no position on the merits of the proposed Moratorium but advises that the Town has received the Safe Streets and Roads for All Grant which will study traffic and pedestrian safety in Ridgefield. This study will be taking place during the time frame in which the moratorium is proposed.
